The normal transit capacity of the Panamax locks is 34-36 vessels per day, depending on vessel mix, neopanamax transits, and other factors. This capacity is reduced during locks maintenance work, as indicated in the above table. Consequently, vessels may experience delays in transiting. When the Panama Canal's capacity is expected to be reduced, a corresponding reduction in the number of available reserved transit slots may be ordered by the Canal Authority. Whenever a set of locks requires a major outage of one of its two lanes for dry chamber inspection, miter gate repairs, tow track work or other major maintenance/improvement projects, advantage may be taken to perform simultaneous single lane outages at other locks.

Panama Canal Welcomes First Cruise Ship through New Locks, Heralding New Benefits to the Cruise Industry and its Passengers

The Expanded Panama Canal welcomed on April 29 its first passenger vessel through the new locks: the Disney Cruise Line Disney Wonder. The milestone signals the further diversification of traffic through the Expanded Canal and with it, introduces new repositioning opportunities for the cruise industry and benefits to its customers.

"The original Panama Canal has been a cruise destination for many years," said Panama Canal Deputy Administrator Manuel Benitez. "Today's historic transit marks the beginning of cruise lines being able to include the new locks as part of their itineraries, opening up additional transit options and allowing cruise passengers to witness first-hand this feat of modern engineering."

The *Disney Wonder* transited the Expanded Canal in a southbound direction from the Atlantic to the Pacific Ocean this marks part of a 14-night voyage from Port Canaveral, Fla., to San Diego, where the ship will sail cruises to Baja, Mexico, before a summer season from Vancouver to Alaska. The Disney Cruise Line 2,713-passenger ship was transformed in late 2016, expanding the length of the *Disney Wonder* to 299.92 meters, now a neopanamax size vessel will require the use of the neopanamax locks.

The *Disney Wonder* is one of several cruise ships to have transited the canal during the 2016-2017 cruise season that ends in May. Notably, the *Disney Wonder's* transit on April 29, marking the first passenger vessel utilizing the new locks of the Expanded Canal.

By the close of fiscal year 2017, ending on September 30th, the Panama Canal expects 233 passenger vessels, which represents a total 237,298 passengers, to have transited both the original and new locks.

On April 1, the Panama Canal began accepting booking requests by passenger vessels for the new locks. To date, 18 reservations for the 2017-2018 season have already been made for passenger vessels to transit the Expanded Canal, a number which is expected to increase in the coming months.
