Panama Canal Authority Long-Term Slot Allocation

The Long-Term Slot Allocation (LoTSA) is a new method for Neopanamax vessels to secure transit slots in the Panama Canal. This method allows customers to reserve transit slot packages through a sealed bid process available in the Panama Canal Transit Auction System.

The following table summarizes the package availability and the slot distribution per package to be allocated the first year through the LoTSA method for booking dates from January 5, 2025, to January 3, 2026:

*All 12 slots per package shall be in the same direction.

The sealed bid processes for the first calendar year period will be held beginning September 9, 2024, for booking dates from January 5, 2025, to January 3, 2026, as shown in the following table:

The LoTSA Packages offered through a sealed bid auction will be subject to the following terms and conditions:

- Customers awarded Long-Term Slots (LoTSA) will enjoy the following privileges without additional charges:

1.1. Swap and Substitution

- 1.1.1. Unlimited swaps and substitutions requested at least two days prior to the required arrival time. Effective April 27, 2025 requests made within 7 days of the required arrival time will not incur a substitution and/or swapping fee. No swap or substitution requested with less than two days from the required arrival time will be allowed.

Effective March 22, 2025, for booking dates beginning March 25, 2025

1.1.2. Customers with LoTSA packages may be approved for unlimited Swaps and Substitutions between LPG and LNG (or vice versa) vessels with the same Customer Code, if requested at least two days prior to the required arrival time, based on Canal capacity and vessel mix. If approved, the vessels will not be subject to a specific In Transit Time (ITT) guarantee.

1.1.3. Full Container Customers with LoTSA packages may be approved unlimited Swaps and Substitutions between vessels with different HML restrictions (excluding vessels with HML=M) within the same Customer Code, Alliance or Vessel Sharing Agreement (VSA), if requested at least two days prior to the required arrival time, based on Canal Capacity and vessel mix. If approved, the vessels will not be subject to a specific In Transit Time (ITT) guarantee.

1.2. Swap and Substitution among LoTSA slots customers within the same market segment group. Effective April 27, 2025, for booking dates beginning May 2, 2025:

1.2.1. Customers with LoTSA packages may be eligible for unlimited Swaps and Substitutions between LPG and LNG (or vice versa) vessels under any Customer Code within LOTSA customers. Approval is based on Canal capacity and vessel mix. If approved, the vessels will not be guaranteed a specific In Transit Time (ITT).

1.2.2. Full Container Customers with LoTSA packages may be approved unlimited Swaps and Substitutions between vessels with different HML restrictions (excluding vessels with HML=M) under any Customer Code within LOTSA customers. Approval is based on Canal capacity and vessel mix. If approved, the vessels will not be guaranteed a specific In Transit Time (ITT).

1.2.3. Procedure:

1.2.3.1. Customers with LoTSA packages that require to cancel a slot due to the unavailability of a vessel for the registered transit slot shall notify the ACP at least four days prior to the required arrival time. In such cases the ACP will coordinate a Substitution with other LoTSA customers not participating in the same alliance or VSA as the customer canceling the LoTSA slot. The customer receiving the slot will be charged the LoTSA Booking Fee based on the bid placed by the original slot holder. If the ACP is unable to allocate the slot three days prior to the required arrival time, the original holder of the slot will retain the slot and will remain responsible for all associated charges. If the Substitution involves full container vessels with different HML restrictions or between LPG and LNG vessels, no maximum ITT will be guaranteed. This benefit will only be allowed once per LoTSA slot.

1.2.3.2. Customers with LoTSA packages that require to cancel a slot because the vessel will not arrive on time for the scheduled transit date, and a change date is not possible, shall notify the ACP at least four days prior to the required arrival time for both vessels, indicating the new required transit date. In such cases, the ACP will coordinate a Swap with another LoTSA Customer not participating in the same alliance or VSA as the customer canceling the LoTSA slot. If approved, each customer will retain their original slot price based on the bid placed. If the ACP is unable to identify a Swap candidate at least three days prior to the required arrival time, the original slot holder retains the slot and remains responsible for all associated charges. If the Swap involves vessels with different HML restrictions or between LPG and LNG, no maximum ITT will be guaranteed. This benefit will only be allowed once per LoTSA slot.

1.2.3.3. Whenever a request for swap or substitution is received, other LoTSA customers will be notified via email with the details of the available slot and the duration of the competition period to request it. Once the competition period is closed, the swap or substitution between different customers not participating in the same alliance or VSA will be allocated to other Customer using the following order:

- Customer with the highest bid, in descending order, from the same LoTSA Offering as the customer requesting the swap or substitution.
- Customer with the highest bid, in descending order, from a LoTSA Offering within the same market segment as the customer requesting the swap or substitution, and in order of the LoTSA Offering's published date.

1.2.3.4. If no requests are received during the competition period and the deadline of three days prior to the required arrival time has not been reached, the slot will be made available to a LoTSA customer on a first-come first-serve basis until the deadline is reached.

1.2.3.5. Swap or substitution requests must involve vessels transiting in the same direction.

1.2.3.6. Subject to ACP validation and management, customers shall notify their intention to swap or substitute a slot by sending an email to LoTSA@pancanal.com. Additionally, the ACP must request cancellation through the booking system, where the request will remain pending until the swap or substitution transaction is either approved or rejected.

1.3. Change Date

1.3.1. Flexibility may be granted for transit up to two days following the booking date without incurring in an additional fee and only one change date can be made per LoTSA, provided that the request is made no less than eight days prior to the required arrival for the original booking date, and subject to vessel's mix and ACP's

approval. The newly requested date will not be subject to a specific In Transit Time (ITT) guarantee.

- 1.3.2.** Change date requests will not be allowed with 60 or more days prior to the reservation date.
 - 1.3.3.** If there is no capacity in the desired date to change, then the ACP will include the request in a waiting list. If a slot becomes available on the desired date, the slot will be offered to the clients in the waiting list, in a descending order based on the request date.
 - 1.4.** Customers with higher bids will have priority over customers with lower bids when assigning the individual window to register the slot.
 - 1.5.** Booking slots acquired via the LoTSA method will be exempt from the High Demand surcharge.
- 2.** Customers awarded Long-Term Slots (LoTSA) have the same options as other booking slots such as Just in time, change date, late arrival and transit date advancement. Effective April 27, 2025, the fee for these services will not be applicable. Please note that all the rules and conditions published on Notice to Shipping N-07 will remain in effect, however the rules expressly included in this LoTSA term and conditions will be the applicable for the LoTSA method.
- 3.** Booking slots obtained through the LoTSA method are not subject to the following condition: Neopanamax vessels that have requested a booking slot for a particular date and were rejected due to unavailability of slots during any booking period (except Period 3), and subsequently obtain a slot for an alternate date, will be allowed to change to the original date without being assessed a fee for the change, provided that they participate in the tiebreaker competition for the slot; and that the reservation for the alternate date was awarded prior to the slot for the original date becoming available. This provision also applies to vessels interested in slots that become available during the second booking period competition. For this provision to be applied, the booking request shall be submitted during the tiebreaker competition (regular or special) for such slots.
- 4.** The Customer Code, the bid amount, number of packages, payment method and guarantor bank will be the only information required to place a bid in the Panama Canal Transit Auction System.
- 5.** A different username is required for each Customer Code that participates in the sealed bid process, as currently required in the Panama Canal Auction System. The system will validate the username, and the Customer Code used to place the sealed bid and will create a key to this information.

6. These sealed bid auctions will be published not earlier than 0800 hours on day one and the closing time will be at 1200 hours on the next day.
7. The auction closing time will not be extended.
8. The initial or base price of the sealed bid auction for each slot included in the package will be \$200,000 USD (Two Hundred Thousand US dollars).
9. Since several LoTSA packages will be offered at the same time, these packages will be awarded to the customer who submits the highest bid during the auction in descending order. If two or more customers submit the same bid amount at the time the auction closes, the allocation of packages between them will be based on the time each bid was received, in descending order.
10. In case there are customers interested in more than one package, and the number of packages offered exceeds the number of customers participating in the auction, one package will be allocated to each customer that participated in the auction by their bid amount, in descending order (from highest to lowest) and the remaining packages will be allocated individually using the same bid amount order within the customers that are interested in more than one package. For example:
 - 10.1. Example 1: 7 packages offered with 7 or more bidders in the auction interested in more than 1 package: the packages will be awarded according to the 7 highest bidders, in descending order. If two or more customers submit the same bid amount at the time the auction closes, the allocation of packages between them will be based on the time each bid was received, in descending order.
 - 10.2. Example 2: 7 packages offered; and less than 7 bidders in the auction, in which there are some of them interested in more than 1 package: the packages will be awarded according to the highest bids in descending order, and the remaining packages will be awarded between the bidders interested in more than 1 package, according to the highest bid, in descending order.
11. Similar to the current auctioned slots procedure, customers awarded Long-Term slots shall submit a particular date booking request in The Transit Reservation System (Booking) Application, as outlined in Table #1. In this request, the customer shall introduce the package code and check the “Long-Term Slot” box.

Note: In addition, Full-daylight restricted vessels, tug-and-barge units and non-self-propelled vessels are not allowed to participate to book their transit through the LoTSA initiative.

12. For each recurring week the same priority procedure presented above will apply.
13. Under this scheme, a LoTSA slot is booked to transit in a specific week or month. The specific transit date should be defined no later than 15 days prior to the beginning of the intended LoTSA week. If the customer fails to submit the desired booking date request for the acquired LoTSA week, the slot will be forfeited, and the customer will be assessed a cancellation fee equal to the sealed bid amount and the slot will be carried over to period 2.
14. In the event of a LoTSA slot cancellation request, a fee equivalent to the auctioned bid amount for the booking slot will be applied. Furthermore, cancellations made with less than 2 days prior to the required arrival time will incur an additional fee of 250% of the reservation tariff (Tariff 1050.IBN1) if the vessel does not arrive within the next 7 days of the booked date, in addition to the cancellation fee for LoTSA slot (Tariff 1050.IBC8). Moreover, as per Notice to Shipping N-7 Canal authorities may cancel the vessel's booking without charge or may waive assessment of a penalty fee if the vessel's late arrival was due to a medical or humanitarian emergency, force majeure or fortuitous event arising between the vessel's last port and its arrival at Canal waters that could not have been reasonably predicted in advance.
15. Slots are not transferable to other customers unless the customers operate within an alliance and meet the requirements specified in the applicable Notice to Shipping N-7 and the Customer Code Issuance, Consolidation and Deactivation Procedures.
16. Once the package is awarded through the LoTSA method, the customer or his corresponding local shipping agent must submit the appropriate LoTSA request at the time the package is awarded. At this time, the customer must specify the payment method that will be used at the time the vessel's visit is assigned to the LoTSA slot; that is, line of credit, payment gateway, revolving fund or bank guarantor. Regarding the payment of slots obtained through the LoTSA method, customers must pay in cash or post a bank guarantee, in the legal currency of the Republic of Panama, not later than 96 hours prior to the transit date.
17. Customers for Full containers LoTSA packages will be able to submit the required day of the week through form #4611. Once the auction is ended, the list of winners will be published, and customers will be assigned the day of the week requested if it is available, otherwise The Canal will offer the opportunity to request a different day. Also, will be assigned the priority window based on the winners' auction order.
18. From the 28 LoTSA slots available per week, a maximum of 6 LoTSA slots may be registered through the Panama Canal Booking System for the same day of the week, up to five (5) for Full container vessels and up to two (2) for all other segments, for a maximum of four (4) slots per direction. Moreover, a maximum of three (3) customers awarded packages with 104 slots for Full containers may request a slot for the same day of the week and a maximum of three

(3) customers awarded packages with 52 slots for Full containers may request a slot for the same day of the week. These limitations (except the 6 LoTSA slots per booking day) will apply from 70 to 15 days prior to the beginning of the intended LoTSA week in which the slot will be registered.

Flexibility may be granted for transit for up to 2 days following the original booking date without charge, provided that the request is made no less than 8 days prior to the required arrival for the original booking date. - Customers awarded Long-Term Slots (LoTSA) have the same options as other booking slots such as Just-in-time, change date, late arrival, and transit date advancement. Effective April 27, 2025 these services will not be charged. - The specific transit date should be defined no later than 15 days prior to the beginning of the intended LoTSA week. Unused LoTSA slots will be carried over to period 2.
